- II. <u>Background of processing / Indication of the purpose for which the personal data are to be processed / Legal basis of processing / Recipients of the personal data:</u>
- 1. Within the framework of the call for applications for the Iris Fischlmayr Awards and Scholarship, JKU processes the personal data of the applicant(s) stated in the respective application and the enclosures, as well as the statements (opinions, convictions, value judgements and scientific statements) and contact details of the external experts (if necessary) obtained within the framework of the decision-making process, for the purpose of deciding on the awarding of the above-mentioned awards and scholarship or in general for the proper (legal) administrative and organizational handling of JKU's internal application-related processes.

If the prize or scholarship is awarded, JKU will process the photographs taken of the selected persons for reporting on the awarding of the prize or scholarship by JKU during the public event, stating the name (first name and surname), including academic titles if applicable, the topic of the dissertation and the dissertation project respectively the Master's or diploma thesis (in short form) via publication on the JKU homepage, the social media channels of the JKU (e.g. Facebook, Instagram, YouTube, Snapchat, Twitter, XING and LinkedIn) and in any reports about the mentioned event in the local press, journals and magazines (print media) for the purpose of informing the public about the fulfillment of the University's tasks. In case of a positive decision on the granting of a scholarship, a scholarship agreement will be concluded between the JKU and the respective applicant.

2. The legal basis for the above-mentioned data processing consists of the preparation of a contract conclusion upon request of the data subject or the establishment, fulfilment and processing of a contractual relationship between the data subject and JKU in accordance with article 6 paragraph 1 letter b GDPR, the performance of tasks in the public or general interest in accordance with article 6 paragraph 1 letter e and paragraph 3 GDPR in conjunction with §§ 2, 3 no. 4 and 11 UG¹ in conjunction with § 95 UG as well as in the legitimate interest of JKU in accordance with article 6 paragraph 1 letter f GDPR in the proper (legal) administration, organisation and handling of the tendering and application process as well as in the documentation of the event and external reporting.

There is no obligation to provide the personal data, but in the event of failure to do so, the above purpose cannot be achieved, in particular, participation in the aforementioned call for tenders will not be possible.

In so far as any sensitive data mentioned in the relevant application or annexes are processed, the legal basis for the processing of such personal data is based on the consent of the data subject. The data subject shall have the right to withdraw his or her consent to the processing of sensitive data at any time, in writing, without prejudice to the lawfulness of the processing carried out on the basis of the consent until revoked.

3. Recipients of personal data are the organizational units of JKU and their support staff necessary for the corresponding processing - in particular the Human Resources Development, Gender & Diversity Management Department, the responsible staff members of the Vice Rectorate for Research, Gender and Diversity and the Human Resources Department; in addition, the subject-specific internal JKU jury chaired by the Vice Rector for Research, Gender and Diversity receives the submitted application documents for decision making as well as internal and/or external evaluators if necessary.

The photographs of the persons concerned, together with the data provided, will - in the event of the award of the prize or grant - be processed exclusively for the purposes described in Section II.1., in this context also published and thus made accessible to everyone. Due to the worldwide availability of such personal data, they can be found with search engines, linked with other information, and also copied and reprocessed for other purposes not covered by the enclosed data protection declaration. Against this background, the personal data can also be found elsewhere, even after erasure on the original website or or social media channels. JKU has no influence over this and therefore assumes no liability.

#### III. Indication of the criteria for determining the storage period:

The personal data will be stored by JKU for the duration of legal retention periods as well as until the expiry of the limitation periods of potential legal claims. Afterwards, the data will be deleted unless there are other legitimate interests of JKU that justify further storage.

#### IV. Information on the rights of the data subjects:

According to the GDPR, data subjects have the following rights:

- Right to information
- Right to correction and erasure
- Right to restriction of processing
- Right to object
- Right to data portability
